

Pupil premium strategy statement 2024-2025 and review of outcomes in the previous academic year for Dry Drayton C of E Primary School



This statement details our school's use of pupil premium funding to help improve the attainment of our disadvantaged pupils.

It outlines our pupil premium strategy, how we intend to spend the funding in this academic year and outcomes for disadvantaged pupils last academic year.

Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, attend school regularly and have equal access to all activities available at school. It is also that all pupils make good or accelerated progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve these goals, including those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker, and young carers. The activities we have outlined in this statement are also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to both common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they are set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Beyond the academic, we use this funding to enrich the educational experiences of our disadvantaged pupils by offering support for them to partake in school clubs, trips, residential and music and swimming (Years 5 and 6 only) lessons.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments, observations, and discussions with pupils indicate poorer oral language skills and vocabulary gaps among some disadvantaged pupils. These are evident from Reception through to KS2.
2	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics than their peers. This negatively impacts their development as readers and writers.
3	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have less support with reading at home than their peers. This negatively impacts their development as readers and progress throughout most of the rest of their academic studies.
4	Internal and external (where available) assessments indicate that maths attainment (including MTC) among some disadvantaged pupils is below that of non-disadvantaged pupils.
5	<p>Our assessments (including wellbeing survey), observations and discussions with pupils and families identified social and emotional issues for some pupils, due to a lack of enrichment opportunities. These challenges particularly affected disadvantaged pupils, including their attainment.</p> <p>Teacher referrals to the SENDCo for support remain relatively high. A small number of pupils (some of whom are disadvantaged) currently require additional 1-1 support with social and emotional needs.</p>
6	<p>Our attendance data over the last 3 years indicates that disadvantaged children's attendance is now only slightly below (0.1%) that of non-disadvantaged pupils when it has been above in the past.</p> <p>Persistence absence figures have been decreasing over the past 3 years (attendance below 90%) but it is still poor compared to PA in non-disadvantaged pupils. We have identified other issues affecting attendance, including health and term time holidays.</p> <p>Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.</p>

Intended outcomes

Part B: Review of the previous academic year 2023-2024

Outcomes for disadvantaged pupils

We have analysed the performance of our school's disadvantaged pupils during the previous academic year, drawing on national assessment data and our own internal summative and formative assessments.

The data demonstrated that:

Reading:

100% of disadvantaged pupils working at age-related expectation compared to 90% of non-disadvantaged pupils

Both groups made 6.1 point progress (6 points expected over the year)

Writing: 100% of disadvantaged pupils working at age-related expectation compared to 80% of non-disadvantaged pupils

Progress was 6 points this being 0.4 points above non disadvantaged pupils

Maths: 90% of disadvantaged pupils working at age-related expectation compared to 84% of non-disadvantaged pupils

Progress was 5.9 points which is 0.2 above non disadvantaged pupils

Combined: 90% of disadvantaged pupils working at age-related expectation compared to 78% of non-disadvantaged pupils

Progress was 6 points, 0.1 above non disadvantaged pupils

Based on all the information above, the performance of our disadvantaged pupils exceeded expectations, and we are at present on course to achieve the outcomes we set out to achieve by 2024/25, as stated in the Intended Outcomes section above.

We have also drawn on school data and observations to assess wider issues impacting our disadvantaged pupils:

Our attendance data over the last 4 years indicates that attendance in 2019/2020 for disadvantaged pupils was 3% above non-disadvantaged children and in 2020/2021 and 2021/2022 it was 1% below, and it was 1.5% below in 2022/2023, however in 2023/2024, disadvantaged pupils' attendance was only 0.1% below that of non disadvantage pupils. We shall continue with this as a focus for our support for 2024/2025 to maintain good attendance.

44% of disadvantaged pupils were 'persistently absent' (attendance below 90%) compared to 0% of their peers during 2021-2022. In 2022-2023, 25% disadvantaged pupils were 'persistently absent' compared to 0% of their peers. By the end of 2023-

2024, no disadvantaged children had an attendance less than 90%, whereas 6% non disadvantaged were below 90% and classified as persistently absent. 28% of our non disadvantaged pupils had below 96% attendance compared to 33% of disadvantaged pupils, 60% of whom took term time holidays which reduced their attendance. Our assessments and observations indicate that absenteeism is negatively impacting some disadvantaged pupils' progress.

Our evaluation of the approaches delivered last academic year indicates that good quality classroom teaching supported by able and well prepared TAs combined with effective assessment to identify children needing targeted support were found to be particularly effective in supporting the needs of disadvantaged children in our school during the previous academic year.

We have reviewed our strategy plan and made changes to how we intend to use some of our budget this academic year by providing opportunities for CPD for teachers and TAs, purchasing resources to aid in teaching and providing targeted support for small groups and one-to-one interventions as mentioned in the information above.

Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback. [EEF evidence on feedback](#) demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- offering a wide range of high-quality extracurricular activities to boost wellbeing, behaviour, attendance, and aspiration. Activities will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and supported to participate.
- offering weekly Forest School sessions and a half termly afternoon of outdoor learning. Activities will focus on building life skills such as confidence, resilience, and socialising.
- Enrichment activities including visits, visitors, sports competitions and activities such as Dry Drayton's Got Talent

Planning, implementation, and evaluation

In planning our new pupil premium strategy, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected, and which activities had been effective.

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils.

We looked at several reports, studies and research papers about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage.

We used the [EEF's implementation guidance](#) to help us develop our strategy, particularly the 'explore' phase to help us diagnose specific pupil needs and work out which activities and approaches are likely to work in our school. We will continue to use it through the implementation of activities.

We have put a robust evaluation framework in place for the duration of our approach and will adjust our plan over time to secure better outcomes for pupils.
